<sup>3</sup>The net cost of health insurance is the difference between premiums earned and benefits incurred. That is, the amount of health insurance spending attributed to nonmedical benefit expenses, such as administrative costs, additions to reserves, rate credits and dividends, premium taxes, and profits. The net cost for private health insurance companies that insure the enrollees in Medicare, Medicaid, Children's Health Insurance Program, and workers' compensation (health portion only) are also included.

<sup>4</sup>Includes health care services delivered by government public health agencies.

<sup>5</sup>Research and development expenditures of drug companies and other manufacturers and providers of medical equipment and supplies are excluded. These are included in the expenditure class in which the product falls because such expenditures are covered by the payment received for that product.
